(a) The Council of Legal Education wishes to advise that there will be a **minimum increase** in fees per annum of 3%.

(b) **Regulation 13(3) (a)** states:

“A student admitted to the Law School from a territory which at the time of admission is in arrears for a period of 12 months or more in its contribution to the budgets of the Council, unless Council permits payment by the territory to be deferred for a specific period shall be required to pay the economic cost so long as that territory is in arrears but shall be reimbursed the difference between the normal fee and the economic cost for any period in respect of which that territory ceases to be in arrears during the student’s course of study at the school”.

The following was agreed by Council on September 6, 2013:-

“Where the defaulting territory has not cleared off those arrears or the student does not pay the full fees, that student will not be awarded the Legal Education Certificate or will not be allowed to register for a subsequent year while the fees are outstanding as the case may be”.
